TERMS AND CONDITIONS

- 1) A booking form must be filled in for any booking (pitch or rental).
- 2) Only a form filled in properly will be considered valid as it gives all the information requested in view of the booking.
- 3) The final decision of acceptance or rejection of the booking lies with the management of the campsite 'Les Châtaigniers' who does not have to justify itself.
- 4) The confirmation of the booking of a pitch follows the acceptance of the following conditions:
 - a. The deposit must be paid to the campsite 'Les Châtaigniers' (bank transfer, postal order **payable to M. Mme CAZENAVE André**) and enclosed with the booking form (50 € per pitch booked).
 - b. The confirmation of the booking and the acknowledgement of receipt of the monies are sent after acceptance by the campsite 'Les Châtaigniers'.
 - c. The deposit is deducted from the invoice only if the dates stated on the booking form have been respected.
 - d. The pitch booked is put at your disposal on the agreed day from 2.00pm. It must be freed on the day of departure by midday. For any extension of your stay, please check with the Management beforehand.
- 5) The confirmation of the rental of a chalet /mobile home follows the acceptance of the following conditions:
 - a. The deposit must be paid to the campsite 'Les Châtaigniers' (cheque, bank transfer, postal order **payable to M. Mme CAZENAVE André**) and enclosed with the booking form. It represents 25% of the total cost of the stay.
 - b. The deposit is deducted from the invoice only if the dates stated on the booking form have been respected.
 - c. Any stay started will be due in full regardless of the reason of its interruption.
 - d. A 300 € + 50 € (housework) deposit is requested on arrival. It will be refunded after the inventory and the schedule of condition have been carried out. In the event of a departure outside business hours, the deposit will be returned by post.
 - e. The rented mobile home or chalet is put at your disposal on the agreed day from 4.00pm. It must be freed on the day of departure before 10.00am. For any extension of your stay, please check with the management beforehand
- 6) Should the number of persons on arrival or during the stay be different to that initially anticipated, please advise immediately the Management in order for it to be rectified.
- 7) Failing the acceptance of the management, any booked pitch unoccupied within 24 hours following the date of arrival indicated on the written booking form, shall be allocated to another person.
- 8) Payment: the payment of the balance concerning the stay booked through this form is compulsory upon arrival at the campsite 'Les Châtaigniers'. All payments will have to be made in cash.
- 9) In the event of a cancellation within 8 weeks prior to the day of your arrival, we will keep the deposit paid. In the event of a cancellation within 3 weeks prior to the day of your arrival, the payment of the whole cost of your stay will requested.
- 10) The booking of a pitch or the renting of chalet / mobile home means the acceptance of the rules enacted by the bylaws attached to this contract.
