GENERAL CONDITIONS and PAYMENT

- 1) For any reservation (pitch or rental), a reservation contract must be completed
- 2) Only a form filled out with precision is considered valid because it provides all the informations needed to consider the reservation.
- 3) The final decision to accept or refuse the reservation depends solely on the Camping "Les Châtaigniers" which does not have to provide the reason.
- 4) The confirmation of the location reservation is consecutive to the acceptance of the following conditions:
 - a. The amount of the deposit must be paid at the campsite "les Châtaigniers" (money orders, bank transfer, cash) and attached to the reservation (60 € per pitch reserved)
 - b. The confirmation of the reservation and the acknowledgment of receipt of these sums are sent by email after agreement of the campsite "les châtaigniers"
 - c. The deposit is only deducted from the invoice if the dates provided on the reservation have been respected.
 - d. Payment of the stay at the latest the day before your departure.
 - e. The rented pitch is made available on the scheduled day of arrival from 2 p.m., it must be vacated on the day of departure at 11 a.m. For any extension, agree with reception beforehand.
- 5) the confirmation of reservation of rentals (chalet, mobile home) is consecutive to the acceptance of the following conditions:
 - a. The amount of the deposit must be paid at the campsite (money orders, bank transfer, cash) and attached to the reservation, it represents 25% of the total amount of the stay.
 - b. The confirmation of the reservation and the acknowledgment of receipt of these sums are sent by email after agreement of the campsite "les châtaigniers"
 - c. The deposit is only deducted from the invoice if the dates provided on the reservation have been respected
 - d. Payment: the payment of the balance of the stay requested by this rental reservation is compulsory on your arrival at the campsite "Les châtaigniers". All payments must be made by checks, holiday vouchers or cash
 - e. deposit of a deposit of € 300 + € 50 on arrival. Returned after inventory and inspection of the inventory (50 € retained for cleaning partially or badly done). In the event of departure outside office hours, the deposits will be destroyed.
 - f. The rental of the mobile home or the chalet is made available on the scheduled day from 4 p.m. It must be vacated on the scheduled day of departure before 10 am. For any extension, agree with reception beforehand.
 - g. In medium and high seasons, the rental of chalet or mobile home is done by the week only and from Saturday to Saturday
- 6) Any booked and started stay is due in full.
- 7) If the number of people is different on arrival, or during the stay, from that initially planned, the correction will be made immediately at the reception.
- 8) Any reserved space, not occupied within 24 hours of the arrival day provided for by a written reservation, will be allocated to another applicant, unless agreed with management.
- 9) In case of cancellation during the 8 weeks preceding your arrival day, we will keep the deposit paid.
- 10) The fact of reserving a location or a rental also implies acceptance of the rules of life laid down in our internal regulations attached to the contract.
